DNA Update

I've contended for some time that all the Edgars are cousins, not in the general sense of the word—of course we all descend from a common ancestor about 25,000 years back. No, I mean we share a common ancestor about 1000 years ago, as told in the *Account of the Surname Edgar* by James H. Lawrence-Archer (his mother was an Edgar).

In the foreword to the book, Lawrence-Archer states "The motive which led the compiler to undertake his task, was a *distrust of Family Traditions*, which although sometimes useful as clues, are quite often the sources of the strangest delusions and pretensions."

Then he goes on to describe the actual evidence he has uncovered to support that the Edgars of Wedderlie are the direct descendants of the Dunbars. The evidence is ancient charters, written in Latin, naming who was present at a signing, or identifying who was obliged to fulfill a certain requirement.

A couple of weeks back, Dr. Bruce Cockburn of the University of Alberta, with whom we have been working to establish the descendency of the Edgars and Dunbars (the Cockburns are also part of that descendency), sent an email. If you recall from Edgar Events [#106](#), he contends that the Edgars and Dunbars, while originally one family, split into two separate surnames approximately in the 1200s or even earlier. He unearthed even more evidence, which I'll let the following email exchange describe (he addressed to me and Debra Dunbar Nowell):

Hi Debra and James,

I was flipping through the book "Mighty Subjects: The Dunbar Earls in Scotland c. 1072-1289" and noticed a reference to a Patrick Dunbar. This Patrick is described as a relative of the earl who was, for a time, the earl's steward (important official in the earl's retinue). There is also a reference in the book to a Patrick, son or grandson of Edgar, who was the clerk to Earl Patrick I of Dunbar.

Do either of your family genealogies include a Patrick Edgar who fits these descriptions? Perhaps this is the source of the genetic link from the Dunbars to the Edgars.

I include these because you can go to the site yourself and draw your own conclusions. My main one being that these texts (translated from the original Latin) provide actual names of living persons, and the text itself gives the proof that the Earls of Dunbar were related to the Edgars.

The next emails I got from Bruce follow:

Your last reference to a Patrick Edgar, "Clerk of Patrick, earl of Dunbar" is probably the same one that I found in the book.

And,

Hi James,

I believe that the Patrick Edgar that I saw referred to in the book was Patrick, son of Walter Edgar. Here is the corresponding charter in the POMS database. On 13 October 1273 Patrick Edgar is being required by Earl Patrick III to give up his land in Lennel to the convent at Coldstream.

And I replied:

Yes, that's the inference I got from the entry shown as:

13 December 1229 X 31 [Son of Edgar \(father of Patrick, Walter, Alan\)](#) relationship
December 1232 [\(Familial relationship\)](#)

The Edgar mentioned here must be Walter, who was the son of the original Edgar, and Walter (and his son, Patrick) must be a cousin of Patrick III. Is that your feeling in this? Is that what "familial relationship" refers to?

According to the Wikipedia entry, Gospatrick II was father of the original Edgar.



Lastly, Bruce replied:

There are evidently several Edgars in the extended family of the Earls of Dunbar. A younger brother of Earl Gospatrick III, was named Edgar. This Edgar married Alice, daughter of Ivo. If Walter Edgar was descended from this Edgar, then Walter would have been a distant cousin of Earl Patrick III, who was the great great grandson of Gospatrick III.

So, there you have it, a fascinating look at the connections and history of nearly 1000 years ago, giving powerful evidence to back up the DNA results. It isn't proof, but surely points to the strong possibility that we're all related—not delusional or pretentious!

Persian Edgars?

On the International Genealogical Index (IGI), I accidentally came across a Simon Edgar, born in 1896 in Turkey. He shows up on a 1913 immigration document into Philadelphia, USA. On examining the document, Simon is a 17-year-old farm labourer of Assyrian ancestors from Yeslaw, in Russia. The document also states he has a brother, Constantine, also in Yeslaw, Russia.

I thought that this was bit odd, a Turkish and Russian connection for the Edgars, are they really Edgars or is it an Anglicised version of a Russian or Turkish name?

1916

Constantine A Edgar April 15th 1916 sailed from Yokohama to Vermont, USA

A merchant aged 35, single, an Armenian from Persia. Last known address Bangkok, Siam

1930

Conrantine Athloon Edgar, a merchant, aged 50, lived in Manchester, England, and sailed from Liverpool to Singapore on the "Antenor" on the 29th March in 1930. His family is listed as :

Mrs Victoria Edgar aged 36

Mstr Andranik Edgar aged 9

Miss Araxy Edgar aged 8

They were listed as "to be settled in Singapore"

1939

In 1939, on board the "Asama Maru" sailing from Yokohama, Japan, to San Francisco, California, Constantine A Edgar aged 59, a textile merchant, a British subject of Armenian race from Istaphan in Iran

Mrs Victoria Edgar aged 44

Miss Araxy Victoria Edgar aged 16

1947 Headstone, Sydney, NSW

Constantine Arathoon Edgar b. 23 Feb 1889 in Julfa, Istahan, Iran. Died in Sydney, Australia 11th March 1947

Victoria Edgar 21st Sep 1894 died 8th Nov 1965

1943

Andranik Constantine Edgar aged 22, buried plot A16 Thanbyuzat War Cemetery, Burma, died 25th November 1943

Nothing else is showing on any index, I decided to search on "Arathoon" as this appears to be a family linked name, possibly Constantine's father's name.

1901

Mackertich Arathoon Edgar married someone in Chorlton, Manchester, in June 1901

1901

On the 1901 census, Arathoon Edgar, b Singapore is a 17-year-old visitor in Didsbury. (I was born in Didsbury!!)

1915

Arathoon Edgar an Armenian in transit through Hawaii from Hong Kong to San Francisco. Final

destination London, England.

1925

Arathoon G Edgar married Kathleen Manuk in June 1925

1929

Mackertich A Edgar died March 1929, aged 61 in Kensington

1956

Arathoon G Edgar died Aug 1956 in Kensington, London, aged 72 (b. 1884)

I decided to do a business check on the family name and found these listed as Armenian companies in Singapore:

Edgar & Company	1871 – 1899	Founded by Galstaun Edgar, had ties with the Co. with the same name in Surabaya in Java.
Galstaun & Company	1878 – 1884	Marcus Galstaun. Had close links to Java.
M. & G. Moses	1839 – 1845	Founded by M. = Mackertich & G. = Galastaum, brothers
Edgar Brothers	1912 – 1968	Founded by Charles, Mackertich, Constantine, Martin and Sarkies. Over time they had offices in Singapore, Kuala Lumpur, Bangkok, Surabaya, England, and Japan. In 1927, they became Edgar Brothers Ltd. Then in 1966 Edgar (Malaysia 1966) Ltd., and in 1967 Edgar (Malaysia) Ltd. and Edgar (Singapore) Ltd.

So, I think I am safe to assume that all of the above records show from one family, an Armenian family of textile merchants based in Singapore. The link with Manchester is logical as 80% of the world's cotton output was from the Manchester area in the late 1800s. An ideal place to be connected with.

The question is, are these Armenian textile merchants really Edgars? An article I read from the Internet shows a thriving Armenian population in the Singapore area that were badly affected by the aftermath of the Japanese attack on Pearl Harbour.

The community of some 95 Armenians, augmented by refugees from Hong Kong and Malaya, faced great uncertainty. Armenians had settled in Singapore since the early 1820s. Some were classified as British as they were born in a British colony. Others from Persia had become naturalized British subjects. Thus the fate of most was sealed once Singapore surrendered. What befell the Armenian community was a microcosm of the larger British community.

This next quote is the clincher:

*Readers may be surprised at some of the Armenian surnames that will be mentioned. Most of the Armenians who came to Southeast Asia were Persian Armenians, and many had been educated in Calcutta. Their surnames were thus Anglicized. For example, **Yedgarian** became **Edgar**, **Setian** became **Seth**, and **Hovakimian** became **Joaquim**.*

And a last word for Andranik Edgar

Phillip Seth and Andranik Edgar were sent as slave labourers to the infamous Thai-Burma railway. Like thousands of others, they succumbed to inhumane living and working conditions. Andranik died from gangrene and Phillip from typhoid. Andranik's memorial plaque rests in the Thanbyuzayat War Cemetery in Burma, while Phillip's lies in the Chungkai War Cemetery in Thailand.

So, that answers the question—not Edgars, but Yedgarian!



Hazel Lewellen, a long time Quartzsite resident, passed away on November 14, 2015 with her husband of 50 years at her side.

Hazel was born in Montreal, Quebec, Canada on July 10, 1913 and lived there until she moved to Toronto, Ontario, Canada in 1941 after her husband was killed in a machine shop accident. She, along with her husband and son, immigrated to the United States, settling in southern California in 1951. She became a naturalized citizen in 1959.

She started work at the US Post Office as the first female letter carrier following her 2nd husband died in an automobile accident. She retired from the Post Office in 1978. In 1980 she and her 3rd husband started RVing full time traveling around the US and Canada, where she still had family. They spent their first winter in Florida; then came to Quartzsite every winter after that. In 1998 they sold their 5th wheel trailer and settled down to stay in Quartzsite.

Hazel is survived by her husband Joe, son and daughter-in-law Erin & Brigitte Jerrett of Arkansas; granddaughters Faith (Joh) Hufft, of Texas; Jami Jerrett (Jason Davenport) of California; and four great grandchildren, Zachary USMC, Donivan, Texas and Angel & Jayden of California.
